Dr. Lindsey Gurin, MD is dually board-certified in neurology and psychiatry and is clinical assistant professor of Neurology, Psychiatry, and Rehabilitation Medicine at NYU Grossman School of Medicine. A graduate of the Alpert Medical School of Brown University, Dr. Gurin completed her combined psychiatry/neurology residency training at NYU and is currently Director of Behavioral Neurology at NYU Langone Orthopedics Hospital, where she provides inpatient neuropsychiatric consultation to the Rusk Brain Injury Rehabilitation Program. She is Director of the NYU Combined Psychiatry/Neurology Residency Training Program and oversees the neurology and psychiatry education components of the NYU Brain Injury Medicine Fellowship. Dr. Gurin's academic work focuses on neuropsychiatric manifestations of acquired brain injury, and she has published on such topics as posttraumatic psychosis, disorders of consciousness, and catatonia in patients with neurologic disorders.
