



CHRISTOPHER BARTOLOTTA

Christopher Bartolotta has been employed by the State of Connecticut's Department of Emergency Services and Public Protection since 1990, currently assigned to Troop "A," Southbury, as the Commanding Officer in the rank of Lieutenant.

Mr. Bartolotta is a certified Law Enforcement Trainer in several states on a wide variety of subjects to include policy and procedure development and implementation, interpersonal communications, unique enforcement techniques, patrol function challenges, interview and interrogation, drug and alcohol issues, stress and crisis management, suicide intervention, fraudulent documents, motor vehicle theft and fraud, report writing and documentation, criminal investigations, as well as numerous other topics.

Mr. Bartolotta was the first officer in the State of Connecticut to be certified as a Drug Recognition Expert and a DRE instructor. Several state courts have recognized him as an expert in matters involving Impaired Driving Enforcement, the Standardized Field Sobriety Tests, Horizontal Gaze Nystagmus and Drug Recognition.

Mr. Bartolotta is a national instructor on underage drinking issues, impaired driving enforcement, fraudulent document recognition, crisis/hostage negotiations and major crime investigations. He has assisted in the publication of two manuals used for law enforcement training. Mr. Bartolotta has regularly lectured at the Pacific Institute for Research and Evaluation's National Leadership Conference during its tenure.

In addition to his vast experience in the field of law enforcement and numerous civic contributions, Mr. Bartolotta has been recognized and has received numerous awards for his accomplishments, which include a DARE Outstanding Student Leadership Award, several MADD high activity/appreciation/education awards, a Texas Alcohol Beverage Commissioners Appreciation award, a CSP Troop "L" High DWI activity award, multiple Commissioner Top 20 marksmanship awards, an Outstanding Leadership Award for efforts regarding Underage Drinking and CSP Department awards for Bravery, Meritorious Service, Life Saving,

Outstanding Service and several Unit Citations, as well as the Sandy Hook Service Ribbon. He has been recognized by the CT Exchange Club as its “Police Officer of the Year” recipient. Mr. Bartolotta was a finalist for the MADD National President’s Award, the highest form of praise from this national organization. Lastly, he has been serving as the head chair of the Connecticut Coalition to Stop Underage Drinking for several years.



NANCY M. MCGEE, JD

Retired Special Agent Nancy McGee served for more than 29 years in the Missouri Department of Public Safety—Division of Alcohol and Tobacco Control. As a special agent stationed in the St. Louis District specializing in alcohol enforcement, McGee was responsible for enforcing Missouri’s Liquor Control Act. She oversaw administering the state’s alcohol compliance check program as well as coordinating the department’s efforts on college campuses and with community coalition groups. McGee was also designated as the division’s liaison officer for local law enforcement agencies that received federal grants through the Office of

Juvenile Justice and Delinquency Prevention - Enforcing the Underage Drinking Laws (OJJDP/EUDL) Program.

McGee has also served as a consultant for the Pacific Institute for Research and Evaluation since August 2002. In that capacity, she has developed course curricula and provided technical assistance and training to agencies in support of alcohol and tobacco initiatives. She regularly provides training on the topics of developing and sustaining community coalitions, environmental management, working effectively with college communities, compliance check investigations, controlled party dispersal, shoulder tap operations, false identification, media advocacy, managing special events, social media and working effectively with retailers.

In 2014 McGee was selected by the Institute of Medicine of the National Academies as an FDA Tobacco Regulatory Science Fellow. McGee spent one year in residency at the FDA Center for Tobacco Products in Silver Spring, MD, where she assisted the Center with issues concerning the implementation and enforcement of the Family Smoking Prevention and Tobacco Control Act (TCA).

Throughout her career, McGee has been a featured speaker and panelist at numerous national conferences on underage drinking issues. She has given presentations at the OJJDP/National Leadership Conference, the Higher Education Center's National Conference, the National Conference of State Liquor Administrators' Midwest Regional Conference, and the Missouri Partners in Prevention "Meeting of the Minds" Conference.

McGee holds a bachelor's degree from the University of Missouri-Columbia and a Juris Doctorate from St. Louis University School of Law. She is licensed to practice law in Missouri and Illinois.



AIDAN J. MOORE, JD

Aidan J. Moore is a Program Director at the Pacific Institute for Research and Evaluation (PIRE). Aidan is the Principle Investigator for the Calverton Training Center which offers training to organizations across the nation on a variety of topics related to alcohol and the law. Aidan serves as a consultant to the NH State Liquor Commission as a Legal Coordinator for legislative and statutory initiatives related to alcohol policy and licensing. Aidan recently authored a white paper for the New

Hampshire Legislature on reforming New Hampshire's alcohol beverage laws.

He formerly managed PIRE's Judicial-Probation Outreach Project and served as a team member at the Underage Drinking Enforcement Training Center (UDETC), which provided training and technical assistance to the 50 states and U.S. territories as part of the Enforcing Underage Drinking Laws program (EUDL). Before joining PIRE, Aidan worked as a local police officer and served as the Chief of Enforcement for the NH State Liquor Commission, retiring after 25 years of law enforcement service to the State of New Hampshire. While in state government he served on the NH Attorney General's Underage Drinking Task Force, the Governor's Task Force on Fatal Accidents, the Governor's Commission on Prevention and Treatment, New Hampshire's SPF-SIG advisory group and most recently, on the New Hampshire Traffic Safety Commission. Aidan also serves the legal community as an alcohol policy expert and provides testimony and consultant services on a variety of issues.

Aidan is a member of the NH Chief's Association, the International Association of Chiefs of Police and a past President of the National Liquor Law Enforcement Association (NLLEA). He is a graduate of the 159th session of the FBI National Academy and the FBI Law Enforcement Executive Development program (LEEDS). He holds graduate degrees from Boston University and Golden Gate University in San Francisco and received his Juris Doctorate from New England Law in Boston. He is admitted to practice law in New Hampshire and Maine.
